NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

In-person requests: *A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).*

Written requests: *Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.*

Website alternative: *Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.*

Permissible charges: *Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.*

Penalties: *An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:*

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

Private foundation exempt: *The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.*

1 Briefly describe the organization's mission: Family Assistance Ministries is a faith-based charitable non-profit organization assisting those in need in southern Orange County with resources for food, shelter, and personalized counsel and aid, helping clients bridge the gap from dependency to self-sufficiency.

(Revenue \$) Hunger Prevention Food Pantry: Emergency and ongoing nutritious food assistance is provided to children, seniors and all who are hungry. This is made possible by our 7-day a week, fresh rescue from local grocery stores and farms, USDA food, senior commodities, and food donations from community partners such as churches, businesses, civic organizations, schools, scouts, and individuals. An average of 4,868 hungry people seek FAM as a food source each month. 1,344 local volunteers make this and other FAM programs possible. Food donations are redistributed at FAM's main Resource Center in San Clemente, satellites in Dana Point and San Juan Capistrano, and with other organizations.

4b (Code:) (Expenses \$ 372,540. including grants of \$ 283,168.) (Revenue \$) Permanent Supportive Housing: FAM launched housing for chronic homeless with a mental or physical disability this fiscal year. FAM is the master lease holder. Clients are provided tenant education, connection to a health home, a support team through FAM's Friendly Visitors Program, case management and wrap around services.

4c (Code:) (Expenses \$ 350,812. including grants of \$ 184,218.) (Revenue \$) Family House: FAM launched the only family emergency shelter in south Orange County to include dads. 52 homeless single dads, dual parent households, single moms and pregnant women were safely housed, offered healthy food choices, connected to health insurance and a health home and development screenings for children 5 and under. Financial counseling, job coaching, and other life skills classes are offered. Food, personal care items, clothing, diapers, back-to-school supplies, holiday gifts, referrals for other social services needed are provided. The goal is to help clients quickly graduate into their own stable housing.
